Mrs. Moore must have moved out of her home by 1945, and it was apparently then leased ~~to~~ *It was sold in 1952 and has had several owners since*

1945-51 Harvey R. Ficklin - projectionist at the Gem Theatre

After this home was sold by Mrs. Katie Moore in 1950, Lee and Bess Stacks continued leasing it to: now a
1950 Harvey Ficklin - film operator, Strand Theater
 and Mrs. Margaret Curtin, practical nurse

In 1952, Marvin Patterson purchased the home and lived there until selling it to Robert Lipscomb in 1957. It was then sold to David L. Darby in 1958. Soon after, it was converted into several apartments and leased to a succession of Air Force personnel until purchased in 1977 by Douglas Walker, who has since been ~~listed~~ listed in the city directory as living there up to the present time. However, I did find the deed whereby Walker sold the house to Ronald Lorenz in 1980. Lorenz was not listed in the tax roll, nor is he listed in the telephone book.

The original red brick trim has been painted white, as has the dark wood stained doorway.

The Moore's previous address as shown in the 1918 City Directory was 1201 Burnett.

John A. Richolt's home was at 1108 Austin St.
