The Wichita County Hazard Mitigation Action Plan provides proposed action items for all of the communities within Wichita County. The table of proposed action items below apply specifically to the City of Wichita Falls. Under the Hazard(s) Addressed column, "Multiple" means any combination of two or more of the following hazards: dam failure, drought, extreme heat, earthquake, flood, hail, lightning, thunderstorm wind, tornado, wildfire, or winter storm.

4. Discuss why any objectives were not reached or why implementation is behind schedule:

The current plan was adopted in July 2024, so there has not been sufficient time for the implementation of most action items. Most action items have an implementation schedule in the plan that provides for implementation within 24 months or 60 months of plan adoption, or as funding becomes available. Therefore, based on the plan's implementation schedule, no actions can be currently considered as behind schedule. The action items that were already occurring with regularity or that were already underway have been identified as ongoing in the previous item's table.

5. What are the recommendations for new projects or revised recommendations?

Again, the current credited plan was only recently adopted in July 2024. There are no recommendations for new projects or revised recommendations at this time. The plan will be monitored and evaluated on an annual basis by a Planning Team to determine if mitigation actions need to be revised or updated starting in 2025.
