Article II Sec. 14-71 of the City of Wichita Falls' Code of Ordinances requires that "No person shall own, possess or harbor a dog or cat, 16 weeks of age (four months) or over, without obtaining a license for each animal." The license may be obtained at the Animal Control Office located in the Wichita Falls-Wichita County Public Health District, through an authorized veterinary office or by completing this application and mailing it, along with the correct fee to: **Animal Services Center, 1207 Hatton Road, Wichita Falls, TX 76302.**

Sec. 14-73 states that "A valid certificate of rabies vaccination and license fee must be presented to obtain a license for a dog or cat."

This license will be a valuable means of identification in the event your dog or cat should become lost, impounded or injured.
